No. 12/PMS-FORMS/2022-TA&H: In pursuance of the Meeting held with various Tribal Students' Unions/Associations on 3rd July, 2026 through hybrid mode, and considering the request of the students' representatives, the **last date** for completing Aadhaar seeding/linking with the respective bank accounts for Direct Benefit Transfer (DBT) under the Pre-Matric and Post-Matric Scholarship Schemes (Academic Years 2023–24 and 2024–25) is hereby extended up to **10th July, 2026**.

The list of eligible students under Pre-Matric and Post-Matric Scholarship Schemes for the years 2023-24 and 2024-25 whose scholarship payments are pending due to non-seeding/non-linking of Aadhaar with Bank Accounts has been uploaded on the Department's website: www.dtahills.mn.gov.in

And whereas, as per the directives of the Government of India, all scholarship disbursements are being transitioned to the **SNA-SPARSH platform** from the Financial Year 2026-27 onwards, requiring Aadhaar-seeded and DBT-enabled bank accounts for successful transfer of scholarship benefits;

Now therefore, in the interest of timely disbursement of scholarships and to avoid forfeiture/surrender of undisbursed scholarship funds to the Government of India, the following is hereby notified for strict compliance by all concerned students, educational institutions, and stakeholders:

1. All concerned students are hereby directed to mandatorily complete Aadhaar seeding/linking with their respective Bank Accounts on or before **10th July, 2026** by visiting their Home Branch or concerned Bank Branch.
2. **Students are advised to ensure that:**
 - i. the Aadhaar number is correctly linked with the active Bank Account;
 - ii. the Bank Account is DBT-enabled;
 - iii. the account details submitted in NSP are correct and active.
3. **All Heads of Educational Institutions are requested to:**
 - i. disseminate this Notification among all concerned students immediately;
 - ii. verify and monitor compliance of Aadhaar seeding by students;
 - iii. extend necessary assistance to students wherever required.
4. Concerned Bank Branches are requested to facilitate Aadhaar seeding/linking of student bank accounts on priority basis to avoid delay in scholarship disbursement.
5. Students covered under the Pre-Matric and Post-Matric Scholarship Schemes for the academic years 2023–24 and 2024–25 whose scholarship payments remain pending due to non-seeding or non-linking of Aadhaar with their bank accounts, and who fail to complete the Aadhaar seeding/linking on or before **10th July, 2026**, shall be

treated as non-genuine or disinterested applicants. Accordingly, the Department will take appropriate action as per the applicable rules and guidelines.

6. Failure to complete Aadhaar seeding/linking within the stipulated timeline may result in non-release/forfeiture of scholarship benefits, and no claim or representation shall be entertained by the Department after the expiry of the notified deadline.
7. **This Notification is issued as a final opportunity in public interest to enable disbursement of pending scholarship amounts to eligible beneficiaries.**
